- PLAYER: PERMISSION TO PLAY IN ANOTHER STATE
- TEAM: PERMISSION TO PLAY IN A LEAGUE OUTSIDE OF VA/DC BOUNDARIES



*Although some surrounding states allow multiple rostering, VYSA requires that a player be rostered on only one VYSA travel team at a time. All teams must be rostered in VYSA if more than 50% of its players are registered in Virginia/DC. If exactly 50% of its players are registered in both Virginia/DC and one other state, the team will determine in which state they wish to be rostered.*

*USYSA Rule 201: Player Registration. Section 1. (Residency) A youth player MUST register each seasonal year in the State Association in which he or she resides with his or her parent or parents or guardian or guardians, or, for a student in residence at a boarding school, college or university, the player may register in the state in which the school, etc., is located. Any other questions of residency may be determined by the State Association in which the player is registered to vote or holds a current driver's license.*

- Directions for Player:**
1. Player must register in the state in which he/she lives.
  2. Player must complete parts 1 and 2.
  3. Submit check payable to VYSA for the appropriate fee if VA/DC player.
- Directions for Team:**
1. Team must complete part 3.
